

# Ashton Elementary School Parental Involvement Policy

## PART I. GENERAL EXPECTATIONS

Ashton Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will ensure that the required school level parental involvement policy meets the requirements of section 1118 of the ESEA, and includes, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

  - *Ashton Elementary will hold parent meetings to explain the frequency / format of progress reports, assessments, and programs used by the school.*
5. Ashton Elementary shall, at the request of parents, provide opportunities for regular meetings, held at flexible times, for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - *Hold Parent-Teacher conferences and student assistance team meetings as requested.*
6. Ashton Elementary shall provide each parent an individual student report about the performance of their child on the State assessment in at least math, and ELA by:
  - *September of each year.*
7. Ashton Elementary shall take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):
  - *Ashton Elementary will provide parents with the following information:  
Requested information about the professional qualifications of the teachers who instruct your children.  
Including grade levels and subjects the WVDE has licensed the teacher to instruct, teachers who have*

*been placed in positions without being qualified under state regulations because of special circumstances, degrees the teacher has earned and the subjects of the degrees.*

8. Ashton Elementary shall provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below --
  - the state's academic content standards,
  - the state's student academic achievement standards,
  - the state and local academic assessments including alternate assessments,
  - the requirements of Title I Part A,
  - how to monitor their child's progress, and
  - how to work with educators:
9. Ashton Elementary shall provide materials and training to help parents work with their children in the areas of improving student achievement, (including literacy training and using technology) child development, child rearing and additional topics parents may request.
  - *Title I funds will be utilized to provide and implement effective parent involvement activities.*
10. Ashton Elementary shall, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - *Ashton Elementary will provide faculty and staff development regarding positive communication and relationship building with parents and community members.*
11. Ashton Elementary shall, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
12. Ashton Elementary shall take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
  - *Ashton Elementary will utilize county adopted student enrollment forms which ask for information on the language spoken in the home.*
